Completion Date: December, 2009
- **Communication and Outreach**
Scope: CMS Communication and Outreach
Completion Date: September, 2010
- **Readiness State Self-Assessment**
Scope: State Readiness –Self-Reported Baseline Assessment
Completion Date: July, 2010

Communication and Outreach

- National Multimedia ICD- 10 Campaign
- Landscape Analysis Conducted:
August 2009 – September 2009
- Uniform Messaging Targeting all Stakeholders, including Medicaid
- Next Steps: Draft Outreach Plans

State Self-Reported ICD-10 Baseline Assessment

Goals:

- Provide CMS with an initial, overall picture of State Medicaid Readiness for ICD-10 Implementation
- Raise awareness and knowledge of ICD-10 within the State Medicaid Agency
- Provide States a comparison of their readiness to the a “national standard” of readiness
- Enable CMS to identify trouble areas and share this information with CMS executives and the States

Steps for ICD-10 Readiness Assessment Implementation

- Communicate Strategy & Goals of assessment to States via CMS Regional and Central Office outreach
- Complete Assessment Tool – December 09
- Post On-Line Self-Assessment Instrument Hosted by Clemson University
- Collect Assessment Responses – January thru February, 2010
- Publish results, dashboard availability – April, 2010

ICD-10 Readiness Assessment Deliverable

- Compares Readiness of one State to the National Standard of Readiness
- National Map of States – Red, Yellow, Green (Similar to Y2K)
- Targets States Needing Technical Assistance at the Front End

Follow Up

- Analysis of assessment results
- Follow up assessment visits by CMS CO and RO teams – assisted by contractor staff
- Update of dashboard tool
- Targeted technical assistance and additional assessments
